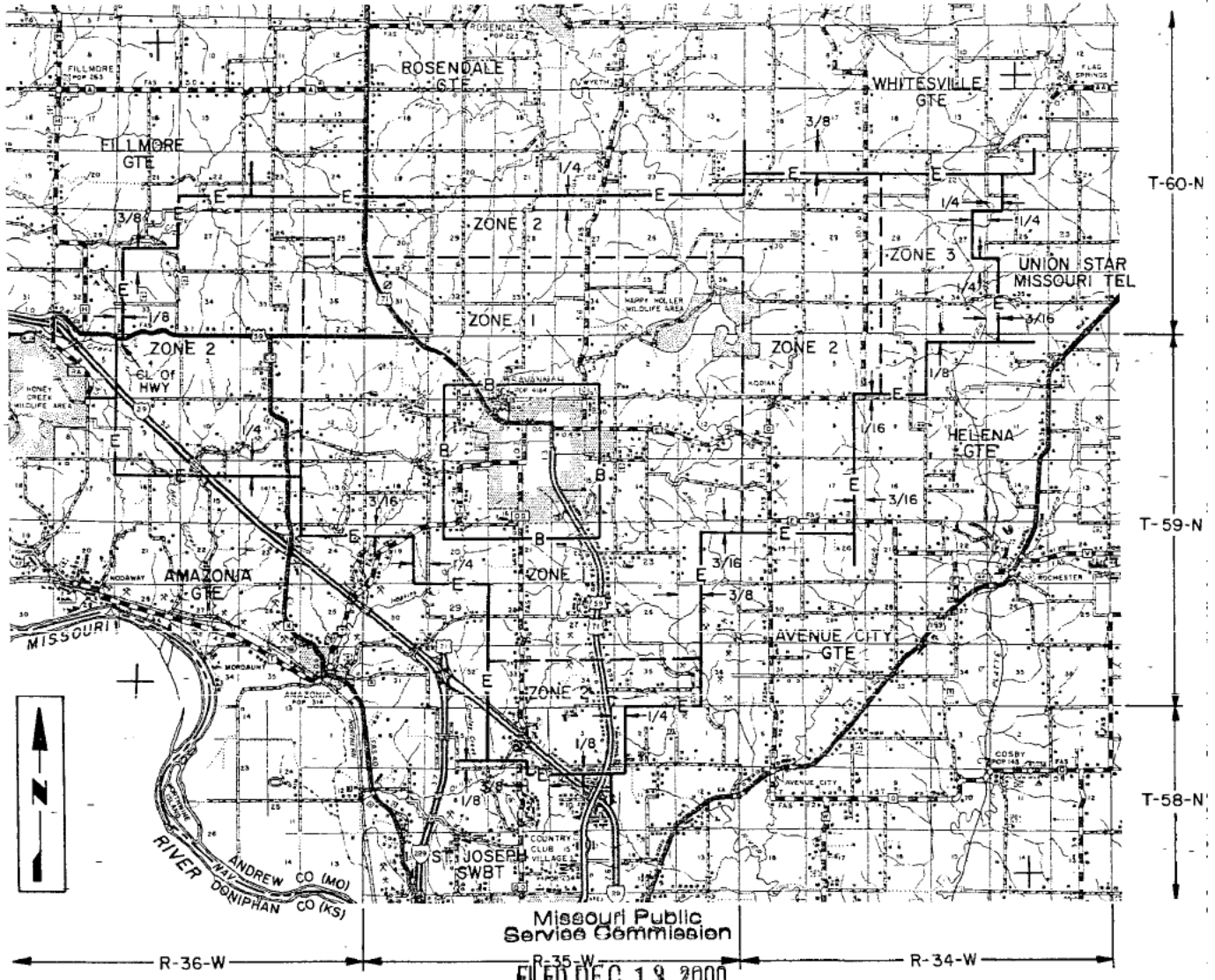
SAVANNAH EXCHANGE
