

**OBJECTION TO THE UNFAIR TREATMENT
BY THE OPPOSING ATTORNEY AND
PROPOSED HEARING SCHEDULE**

Comes now, Mr. Craig Mershon to object to the poor treatment provided by the opposing attorney and personnel at the pre hearing conference held on October 16, 2013. A pre hearing conference was held on October 16, 2013 to discuss options and a possible solution to the complaint filed against Ameren Union Electric Company a/b/a/ Ameren Missouri. Once the Regulatory Judge left the room the opposing attorney Ms. Sarah Giboney and other attorneys in the room began to ask Mr. Mershon questions about his testimony and email address and his proposed date for a hearing.

Mr. Mershon could not decide when he wanted the hearing because he was in the pre hearing stage. The opposing attorneys wanted all pleadings stopped within a few weeks. Mr. Christopher Worth, Grass Roots Organizer for Paraquad Center for

Independent Living suggested that Mr. Mershon needed 10 to 12 weeks to organize his case.

The opposing attorneys objected even given the fact that Mr. Mershon has a visual and physical disability. It will take him time to draft his argument and statement because of his limited vision and physical disability. This was brought up and it was disregarded. Mr. Mershon feels that he is at a disadvantage because of his disability and race.

The opposing attorney wanted Mr. Mershon's email address even after he protested saying it was difficult for him to read emails online because of his visual disability. The opposing attorney continued to press Mr. Mershon to give her his email address and promised she would send everything through the mail for Mr. Mershon to see. She immediately filed for a proposed hearing date. As she filed for a proposed hearing date she fixed the information in a downloaded format making it difficult for Mr. Mershon to access it. Mr. Mershon was not given the opportunity to file his dates. This is putting Mr. Mershon at an unfair disadvantage because he will not have the right to make a decision on his own case.

Therefore, Mr. Mershon is requesting a phone conference in reference to these problems so they may be addressed properly. He should not be treated in such a disrespectful manner. Mr. Mershon will be available Monday, Tuesday, or Wednesday, of the following week for a conference to be set up. The best time would be 1:00 PM for a conference.
