ORDER APPROVING TARIFF

Issue Date: September 20, 2018 Effective Date: October 1, 2018

On September 1, 2018, Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty Utilities ("Liberty") filed Tariff Tracking Number JG-2019-0041, with a proposed effective date of October 1, 2018. The tariff would revise Liberty's weather normalization adjustment rider ("WNAR"), and is a mandatory semi-annual filing pursuant to Liberty's WNAR tariff, which went into effect on July 1, 2018.

On September 17, 2018, the Commission's Staff filed a recommendation that the Commission approve the tariff. No WNAR rate adjustment is being made. No other party responded or opposed approval of the tariff. The Commission has reviewed the tariff and Staff's verified recommendation and memorandum. The Commission will approve the tariff.

Section 386.490, RSMo, states "Every order or decision of the commission shall of its own force take effect and become operative thirty days after the service thereof, except as otherwise provided." The Commission finds good cause for the order to take

effect before thirty days' notice. Liberty's current WNAR ends effective September 30, 2018.

THE COMMISSION ORDERS THAT:

- 1. The tariff sheets filed by Liberty on September 1, 2018, Tariff Tracking Number JG-2019-0041, are approved to become effective on October 1, 2018.
 - 2. This file shall be closed on October 2, 2018.
