## **ORDER RECOGNIZING NAME CHANGE AND APPROVING TARIFFS**

On November 4, 2008, Qwest Communications Corporation filed notification of its change of corporate name to "Qwest Communications Company, LLC" and new tariff sheets reflecting the name change. The tariffs originally had an effective date of January 2, 2009. The Company filed numerous substitute tariff sheets and the tariff effective dates were extended to January 30, 2009.

The Staff of the Missouri Public Service Commission filed a verified recommendation on January 21, 2009. Staff recommends that the Commission recognize the new name. Staff states that the company's application clearly sets out the old name and new name, includes evidence of registration of the name change with the Missouri Secretary of State, and includes an adoption notice and new cover page bearing the new name for each of the company's three tariffs.

The Commission has reviewed the application and Staff's recommendation. The Commission finds that the name change shall be recognized and the proposed tariff sheets shall be approved.
