Dear Mr. Woodruff:

On December 17, 2015, Union Electric Company d/b/a Ameren Missouri (Ameren Missouri or Company) submitted several revised tariff sheets that were part of Schedule No. 6, Schedule of Rates for Electric Service, including 2nd Revised Sheet No. 58 which was to supersede 1st Revised Sheet No. 58. These sheets were filed to add LED rates to the Company's Rate 5M – Street and Outdoor Area Lighting. They bore an effective date of January 16, 2016.

A change in the language regarding High Pressure Sodium and Mercury Vapor offerings under sections C. and D. necessitates substituting the attached tariff sheet for the 2nd revised tariff sheet no. 58 filed on December 17. The change to the language is below:

The High Pressure Sodium and Mercury Vapor offerings under sections C. and D. below will only be available for new installations through on or about March 31, 2016. After such time, Company ~~anticipates~~ **will** replacement of these existing fixtures, upon failure, ~~to~~ **with** an LED fixture under sections A. and B.

The tariff substitution has been discussed with Staff and the Office of the Public Counsel.

These tariff sheets are being issued December 17, 2015 to become effective on and after January 16, 2016.

The revisions being requested will add LED rates to the Company's Rate 5M – Street and Outdoor Area Lighting – Company-Owned tariff for “enclosed” and “open bottom” type lights and provide for converting customers from existing high-pressure sodium and mercury vapor offerings to LED for those same light types. The conversion is expected to occur over approximately five (5) years and will result in customer savings through lower rates of approximately \$1.9 million per year once completed.

The Company has also removed several grandfathered former subsidiary light offerings that are no longer in service or billed to customers.

Concurrent with this tariff, the Company is also filing its LED Street and Outdoor Area Lighting Report for 2015.

The proposed tariff has been discussed with Staff and the Office of the Public Counsel.
