## NOTICE OF SMALL FORMAL COMPLAINT INFORMATION FOR COMPLAINANT AND ORDER DIRECTING STAFF TO INVESTIGATE AND FILE A REPORT

On August 13, 2013, the above-named Complainant filed the attached complaint with the Missouri Public Service Commission against Ameren Missouri.

Commission rule 4 CSR 240-2.070(15) defines a Small Formal Complaint as one with an amount in dispute of less than \$3,000. At paragraph "e" of the complaint, Complainant states a balance of \$808.08 as being an outstanding balance transferred to a new account. The Commission will therefore presume this complaint to be valued at less than \$3,000 and will proceed under the small complaint procedure. Any party may dispute this presumption by filing a motion requesting that the status of the complaint be changed.<sup>1</sup>
