ORDER APPROVING PGA TARIFF

Issue Date: December 2, 2021

Effective Date: December 8, 2021

On November 22, 2021, Summit Natural Gas of Missouri, Inc. (Summit) filed proposed tariff sheets to reflect changes in its Regular Purchased Gas Adjustment (PGA) factor as a result of estimated changes in the cost of natural gas. The tariff sheets also reflect adjustments to Summit's Actual Cost Adjustment (ACA) factors. The tariff sheets bear an effective date of December 8, 2021. A substitute tariff sheet was filed on November 23, 2021, to correct a typographical error.

Summit's proposed PGA factors are:

- For the Gallatin Division, the change will increase the firm sales customers' Total PGA from \$0.3779 per Ccf to \$0.6547 per Ccf. The proposed change represents a \$0.2768 per Ccf increase.
- For the Warsaw and Lake of the Ozarks Divisions, the change will increase the firm sales customers' Total PGA from \$0.3778 per Ccf to \$1.0093 per Ccf. The proposed change represents a \$0.6315 per Ccf increase.
- For the Rogersville and Branson Divisions, the change will increase the firm sales customers' Total PGA from \$0.4216 per Ccf to \$1.0208 per Ccf. The proposed change represents a \$0.5992 per Ccf increase.

The Staff of the Commission (Staff) filed a recommendation on November 29, 2021. The Commission directed responses to Summit's proposed tariff sheets or Staff's recommendation be filed no later than December 1, 2021. No responses were filed.

In its recommendation, Staff stated that the rates in the proposed tariff sheets, Tariff No. YG-2022-0160, were calculated in conformance with Summit's PGA tariff, including the carrying cost application. Due to the limited time available to review the documentation supporting the ACA factors Summit submitted in its filing, Staff requests permission to submit its results and recommendations regarding the information included in this ACA filing to the Commission on or before December 15, 2022.

The Commission has reviewed the proposed tariff sheets and Staff's recommendation. The Commission finds that the proposed tariff sheets conform to Summit's Commission-approved PGA tariff. In addition, because Summit's PGA clause allows for PGA change filings to take effect after ten business days, good cause has been shown pursuant to Section 393.140(11), RSMo 2016, to permit the tariff and this order to become effective on less than 30-days' notice. The Commission concludes the proposed tariff sheets should be approved to become effective on December 8, 2021, on an interim basis, subject to refund, pending final Commission decision in this file and File No. GR-2021-0124. Further, the Commission will also direct its Staff to file the results of its ACA review in this case no later than December 15, 2022.

THE COMMISSION ORDERS THAT:

1. The tariff sheets assigned Tracking No. YG-2022-0160, as substituted, are approved on an interim basis and subject to refund, pending final Commission decisions

in this file and in File No. GR-2021-0124. The tariff sheets approved are:
