ORDER APPROVING PGA TARIFF

Issue Date: January 26, 2022

Effective Date: February 1, 2022

On January 18, 2022, Summit Natural Gas of Missouri, Inc. (SNGMO) filed proposed tariff sheets to reflect changes in the company's Regular Purchased Gas Adjustment (RPGA) factor as a result of estimated changes in the cost of natural gas. The tariff sheets do not change SNGMO's Actual Cost Adjustment (ACA) factors. The tariff sheets bear an effective date of February 1, 2022.

SNGMO proposes reductions in RPGA rates for all customer classes by division as follows:

- For the Gallatin Division, the change will decrease the firm sales customers' Total PGA from \$0.6547 per Ccf to \$0.5938 per Ccf. The proposed change will cause an average winter month residential gas bill to decrease by approximately \$7.76, representing a 4.37% decrease.
- For the Warsaw and Lake of the Ozarks Divisions, the change will decrease the firm sales customers' Total PGA from \$1.0093 per Ccf to \$0.9121 per Ccf. The proposed change will cause an average winter month residential gas bill to decrease by approximately \$5.93, representing a 4.23% decrease.

For the Rogersville and Branson Divisions, the change will decrease the firm sales customers' Total PGA from \$1.0208 per Ccf to \$0.9221 per Ccf. The proposed change will cause an average winter month residential gas bill to decrease by approximately \$9.53, representing a 5.08% decrease.

The Commission directed a recommendation and other responses to SNGMO's proposed tariff sheets be filed no later than January 24, 2022. The Staff of the Commission (Staff) filed its recommendation on January 24, 2022. No other responses were filed.

In its recommendation, Staff stated that the rates in the proposed tariff sheets, Tracking No. JG-2022-0209, were calculated in conformance with SNGMO's PGA tariff.

Staff states that File No. GR-2022-0190, the present case, was established to track SNGMO's PGA factors to be reviewed in its 2021-2022 ACA filing. File No. GR-2022-0122 was established to track SNGMO's PGA factors to be reviewed in its 2020-2021 ACA filing. File No. GR-2021-0124 was established to track SNGMO's PGA factors to be reviewed in its 2019-2020 ACA filings. The rate changes proposed in the present case should be made on an interim basis, subject to refund, and pending final Commission decisions in ACA File Nos. GR-2022-0190, GR-2022-0122, and GR-2021-0124.

The Commission has reviewed the proposed tariff sheets and Staff's recommendation. The Commission finds that the proposed tariff sheets conform to SNGMO's Commission-approved PGA tariff. In addition, because SNGMO's PGA clause allows for PGA change filings to take effect after ten business days, good cause has been shown pursuant to Section 393.140(11), RSMo 2016, to permit the tariff and this order to become effective on less than 30-days' notice. The Commission concludes the proposed

tariff sheets should be approved to become effective on February 1, 2022, on an interim

basis, subject to refund, and pending final Commission decision in this file and File Nos.

GR-2022-0122, and GR-2021-0124.

interim basis and subject to refund, pending final Commission decisions in this file and in
