Dear Mr. Woodruff:

On July 25, 2016, Union Electric Company d/b/a Ameren Missouri (Ameren Missouri or Company) submitted 4th Revised Sheet No. 73.11, which is part of Schedule No. 6, Schedule of Rates for Electric Service, and which was to supersede 3rd Revised Sheet No. 73.11 (the "Original Tariff Sheet"). The Original Tariff Sheet was filed to effectuate the change in the FAR₂₂ rates provided for in the Company's Rider FAC, and bore an effective date of September 23, 2016 (which is the first billing day of the October 2016 billing month).

The Commission's Staff has been engaged in review of the Original Tariff Sheet and the related Fuel Adjustment Rate ("FAR") filing made in this docket, and as part of its review contacted the Company about a minor rounding error on line 9. The Staff indicated to the Company that the Rider FAC filing made on July 25 is otherwise in compliance with the terms of Rider FAC and the Commission's rules.

More specifically, when including only 6 significant figures in the work papers for FAR₂₁ on line 8 of 4th Revised Sheet No. 73.11 (i.e., \$0.00000), the FAR₂₂ on line 9 rounds to \$0.00057 instead of \$0.00056, as had been indicated on the Original Tariff Sheet. Consequently, submitted herewith is a substitute tariff sheet showing the FAR on line 9 as \$0.00057. This substitute tariff sheet will implement the Company's Fuel and Purchased Power Adjustment for the 22nd Accumulation Period ending May 31, 2016, and also includes the amounts to be trued-up for the 19th Recovery Period under the Company's Rider FAC. This substitute tariff sheet bears the same effective as the Original Tariff Sheet, September 23, 2016.
