ORDER APPROVING COMPLIANCE TARIFFS

Issue Date: December 14, 2022

Effective Date: December 27, 2022

On December 8, 2022, the Commission issued an Order Approving Acquisition of Assets and Granting Certificate of Convenience and Necessity, effective December 18, 2022. Among other things, that order directed Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) to submit tariff sheets applicable to the water service and sewer service in the requested service area in P.S.C. MO No. 12 (water) and 13 (sewer), to become effective before closing on the assets.

On December 9, 2022, Confluence Rivers filed new tariff sheets purporting to be in compliance with the terms of the Commission's December 8th order. The new tariff sheets carry a 30-day effective date of January 8, 2023. In addition, Confluence Rivers filed a *Motion for Expedited Treatment* seeking a Commission order approving the proposed tariff sheets to go into effect with less than 30 days' notice on December 27, 2022. Confluence Rivers states that an expedited effective date of the tariffs will further the public interest because there is a need to have Confluence Rivers begin operating the systems expeditiously so that needed improvements to the operation and maintenance of the sewer system can be made.

On December 13, 2022, Confluence Rivers filed two substitute tariff sheets to correct typographical errors. The Staff of the Commission (Staff) filed its recommendation that all of the revised tariff sheets – both those filed on December 9 and the substitute sheets filed on December 13 – be approved.

Upon reviewing the pleadings and Staff's recommendation, the Commission finds Confluence Rivers' proposed tariff sheets comply with the Commission's December 8th Order and will approve them. Further, the Commission finds good cause exists to make the tariffs effective in less than 30 days. Additionally, so that the tariffs can become effective on December 27, 2022, the Commission finds it reasonable for this order to be effective in less than 30 days.

THE COMMISSION ORDERS THAT:

1. The following proposed tariff sheets filed by Confluence Rivers on December 8, 2022, and December 13, 2022, and assigned Tracking No. YW-2023-0106 (water) and Tracking No. YS-2023-0107 (sewer), are approved to become effective on December 27, 2022:
