**ORDER REGARDING TARIFF AND DISPOSITION AGREEMENT**

Issue Date: April 30, 2014

Effective Date: April 30, 2014

The Missouri Public Service Commission is:

- Granting *The Office of the Public Counsel's Request for an Evidentiary Hearing.*
- Granting the motion to suspend the tariff.

The Commission is also reserving ruling on the disposition agreement.

Terre du Lac Utilities Corporation ("the utility") initiated this action by applying for a rate increase.<sup>1</sup> Staff filed a disposition agreement,<sup>2</sup> ("agreement") providing for the filing of schedules for rates and terms for service ("the tariff"), which the utility filed<sup>3</sup> with a proposed effective date of May 15, 2014. The agreement provides for a full resolution of the utility's request between Staff and the utility but does not include the Office of the Public Counsel ("OPC"). OPC filed a motion to suspend the tariff ("motion") as part of a request for a local

public hearing.<sup>4</sup> The Commission reserved ruling on the suspension of the tariff<sup>5</sup> and convened a local public hearing.<sup>6</sup> Staff filed a statement that the local public hearing revealed no information changing Staff's endorsement of the agreement.<sup>7</sup> OPC filed *The Office of the Public Counsel's Request for an Evidentiary Hearing* ("request") including a list of issues.<sup>8</sup>

On the filing of such a request, the Commission's regulations provide that the Commission shall initiate a contested case, which includes the right to an evidentiary hearing. Contested case procedure also allows waivers of procedural formalities<sup>9</sup> and a decision without a hearing,<sup>10</sup> including by stipulation and agreement.<sup>11</sup> The Commission may issue notices and rulings regarding the contested case separately. Therefore, the Commission will grant the request.

The Commission's regulations also provide that, on the filing of such a request, the Commission shall suspend the tariff.<sup>12</sup> The statutes allow the Commission to suspend a tariff for 120 days beyond the tariff's effective date<sup>13</sup> and, if that period is not enough time to conclude a full hearing on the tariff's propriety, to extend the suspension for a further six

months.<sup>14</sup> But the Commission's regulations provide that the Commission's decision and order in this action shall be effective no more than 11 months after this action began.<sup>15</sup> That date is September 21, 2014. Therefore, the Commission will grant the motion.

Therefore, the Commission will reserve ruling on the agreement, grant the request for an evidentiary hearing, and suspend the tariff.

**THE COMMISSION ORDERS THAT:**

1. *The Office of the Public Counsel's Request for an Evidentiary Hearing* is granted.
2. The motion to suspend the tariff is granted. The tariff to which the Commission assigned Tracking No. YS-2014-0369 is suspended from May 15, 2014, for 120 days to September 12, 2014; and that period is extended by nine days to September 21, 2014. The specific tariff suspended is:

3. This order shall become effective immediately on issuance.
