ORDER APPROVING QUARTERLY COST ADJUSTMENT TARIFF

Issue Date: February 14, 2022

Effective Date: March 1, 2022

On January 18, 2022, Evergy Missouri West Inc., d/b/a Evergy Missouri West (Evergy West) filed steam tariff sheets (Tariff No. YH-2022-0208) to change the calculation of Evergy West's Quarterly Cost Adjustment Rider for steam service. The tariff sheets have an effective date of March 1, 2022. On January 18, 2022, the Commission issued an order directing its Staff to file a recommendation on, and allowing any other party to respond to, the application by February 10, 2022. On February 10, Staff filed a recommendation stating that it has reviewed the tariff sheet and the mathematical calculations Evergy West provided and is of the opinion that Evergy West has calculated the QCA for the fourth quarter of 2021 in accordance with the appropriate tariff provisions. Staff recommends the Commission approve the proposed tariff sheet or allow it to become effective by operation of law. No other responses to the tariff sheet were filed.

The Commission has reviewed Evergy West's tariff sheet and Staff's verified recommendation. Based on these filings, the Commission finds that the tariff sheet is in compliance with the Commission's previous orders and Evergy West's current tariff provisions. The Commission approves the tariff sheet as ordered below.

THE COMMISSION ORDERS THAT:

1. Tariff No. YH-2022-0208, submitted on January 18, 2022, is approved to become effective March 1, 2022. The tariff sheet approved is:
