ORDER CANCELLING CERTIFICATES OF AUTHORITY AND CANCELING TARIFF

Issue Date: October 11, 2022 Effective Date: November 10, 2022

On September 27, 2022, the Staff of the Commission (Staff) filed a motion recommending that the Commission cancel the certificate of interexchange telecommunications service authority and Tariff No. YX-2003-1847 of X2Comm, Inc. d/b/a DC Communications (Company). In its motion, Staff states that the Company filed a letter with the Commission on July 7, asking the Commission to cancel its certificate and tariff. The Commission previously granted the certificate to the Company in File No. XA-2003-0451. On September 27, the Commission issued an order allowing ten days to respond to Staff's recommendation and no party has responded within that period.¹

The Commission has the authority to cancel a telecommunications certificate pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

¹ Commission Rule 20 CSR 4240-2.080(13) allows parties ten days to respond to any pleading unless otherwise ordered by the Commission.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. ²

Based on Staff's recommendation, the Commission will cancel the registration granted to the Company, and its applicable tariff.

THE COMMISSION ORDERS THAT:

- 1. The Company's certificate of service authority to provide interexchange and telecommunications service granted in Case No. XA-2003-0451 is cancelled.
- 2. The Company's tariff for interexchange services with tracking number YX-2003-1847 is cancelled.
 - 3. This order shall become effective on November 10, 2022.
 - 4. This file may be closed on November 11, 2022.
