ORDER GRANTING MOTION FOR EXPEDITED TREATMENT AND APPROVING COMPLIANCE TARIFFS

Issue Date: May 22, 2017

Effective Date: May 23, 2017

On May 19, 2017, Missouri-American Water Company (MAWC) filed tariffs purporting to comply with the Commission's Order Granting Certificate of Convenience and Necessity. MAWC also filed a motion for expedited treatment requesting that the tariffs become effective by May 23, 2017, or as soon thereafter as the Commission can address them. The tariffs bear an effective date of June 18, 2017. However, MAWC stated that a closing on the assets, as approved in the Commission's order, is set for May 23, 2017, and this is the reason for the request for expedited treatment. MAWC also filed substitute tariff sheets.

The Staff of the Missouri Public Service Commission (Staff) filed a recommendation on May 22, 2017. Staff stated that it had been working with MAWC during its tariff preparation to assure that the tariffs complied with the Commission's order. Staff stated that it had reviewed the tariff sheets as substituted and found them to be in compliance with the Commission's order. Staff recommended that the tariff sheets be approved on an expedited basis so that they may be effective at the closing of the property sale.

After reviewing the motion for expedited treatment, the tariffs, and Staff's recommendation, the Commission finds that Tariff Nos. YW-2017-0244 and YS-2017-0245 comply with the Commission's order and should be approved. Further, because the closing on the assets is scheduled for May 23, 2017, the Commission finds there is good cause to expedite the effective date of the tariffs so that the company does not operate without tariffs in effect.

THE COMMISSION ORDERS THAT:

1. The Motion for Expedited Treatment filed on May 19, 2017 by MAWC is granted.
2. The tariff sheets filed on May 19, 2017, in Tariff No. YW-2017-0244, as substituted, are approved effective May 23, 2017. The tariff sheets approved are:
