**ORDER CANCELING CERTIFICATES OF SERVICE AUTHORITY AND TARIFF**

Issue Date: May 18, 2007

Effective Date: May 28, 2007

On April 9, 2007, the Staff of the Missouri Public Service Commission filed a motion to cancel the certificates of service authority granted to Group Long Distance, Inc. Staff states that the Commission granted the company a certificate to provide intrastate interexchange and telecommunications services to Group Long Distance, Inc. in Case No. TA-97-72. The Commission approved the company's tariff, PSC MO TARIFF No. 1 in the same case. The Commission also granted the company a certificate of service authority to provide basic local telecommunications service in Case No. TA-98-112. The company never submitted a tariff for those services.

Staff states that the web site of the Missouri Secretary of State shows that the company's authority to do business in the state of Missouri was revoked in December of 2002 for failure to file an Annual registration Report. Staff also states that it has been unable to reach the company by telephone and that mail sent to the company has been returned. Staff goes on to state that no customers have contacted the Commission with complaints about the company.

Under Commission rule 4 CSR 240-2.080(15) parties shall not be allowed more than ten days in which to file a responsive pleading. More than ten days have expired since Staff filed its motion and the company has not responded.

Section 392.410.5, RSMo 2000, states: "Any certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected. . . ." The Commission has reviewed Staff's motion and finds that granting the motion is reasonable. The Commission will therefore cancel the certificates of service authority granted to Group Long Distance in Case Nos. TA-97-72 and TA-98-112 and the company's tariff.

**IT IS ORDERED THAT:**

1. The certificate of service authority to provide intrastate interexchange telecommunications services granted to Group Long Distance, Inc. in Case No. TA-97-72, is canceled.
2. The certificate of service authority to provide basic local telecommunications service granted to Group Long Distance, Inc. in Case No. TA-98-112, is canceled.
3. Group Long Distance, Inc.'s tariff, P.S.C. Mo. TARIFF No. 1, is canceled.
4. This order shall become effective on May 28, 2007.
5. This case may be closed on May 29, 2007.
