**ORDER APPROVING FUEL
ADJUSTMENT CLAUSE TARIFF AND TRUE-UP**

Issue Date: May 15, 2019

Effective Date: June 1, 2019

The Empire District Electric Company ("Empire") filed a tariff and supporting testimony in both of these cases. The Commission's Staff filed a favorable recommendation, and no opposition was received.

In File No. EO-2019-0302, Empire seeks the Commission's approval of true-up amounts related to the company's fuel adjustment clause ("FAC"). Specifically, the amounts relate to the company's Recovery Period 19. Those amounts are components of the FAC for the company's Accumulation Period 21, which is the subject of File No. ER-2019-0301. In that case, Empire asks to increase the company's rates per kilowatt hour ("kWh") to \$0.00345 for primary service and \$0.00351 for secondary service effective June 1, 2019. For a residential customer using 1,000 kWh per month of secondary service, the tariff

increases the Fuel Adjustment Charge by approximately \$4.38 per month, from \$(0.87) to \$3.51.

On the basis of the verified and uncontested filings, the Commission concludes that the tariff conforms to the applicable statutes, regulations, and tariffs. Therefore, the Commission will approve the tariff. The tariff carries an effective date of June 1, 2019; therefore, the Commission will make the order effective with less than 30 days' notice to coincide with the tariff effective date.

THE COMMISSION ORDERS THAT:

1. The tariff assigned Tracking No. JE-2019-0178 is approved to become effective on June 1, 2019, subject to true-up and prudence review.
2. The specific tariff sheet approved is:
