The enclosed tariff sheets reflect various revisions that have been recommended to and approved by the EEC to align the residential offerings and incentives of the Laclede Gas and Missouri Gas Energy operating divisions of Laclede Gas Company as well as enhance the Commercial and Industrial rebate program measures and incentives. Certain revisions were also necessary to conform to new Department of Energy minimum standards for residential water heaters that will go into effect on April 16, 2015.
