**RE: Notice of Granby Telephone Company to Partially Detariff Pursuant to Section 392.461, RSMo. and 4 CSR 240-28.070(6).**

Dear Secretary Woodruff:

Section 392.461, RSMo. allows telecommunications companies, upon notice to the Commission, to elect to be partially exempt from the requirement that they offer retail services to residential or business end users through tariff, and to withdraw such tariffs.

Pursuant to 4 CSR 240-28.070(6), Granby Telephone Company hereby provides notice of its election to be exempt from tariff filing requirements for local service and new Bundled Packages effective June 1, 2016. Please note that while currently available Bundled Packages will be detariffed, Granby will retain its tariffs for bundled service offerings that have previously been grandfathered.
