ORDER SUSPENDING TARIFF

On August 27, 2018, KCP&L Greater Missouri Operations Company (GMO) filed a tariff under Tariff Tracking No. JE-2019-0026 to revise its Limited Large Customer Economic Development Rider. The tariff bears an effective date of September 26, 2018.

On September 25, 2018, the Commission's Staff filed a Motion to Suspend Tariff Sheet and Open New Docket, stating that a substantive dispute may exist regarding the proposed tariff and recommending that the Commission suspend the tariff to provide an opportunity for parties to file information pertaining to the revised tariff. The Commission will suspend the filed tariff for 120 days to consider whether it should be approved.

THE COMMISSION ORDERS THAT:

1. The tariff submitted under Tariff Tracking No. JE-2019-0026 by KCP&L Greater Missouri Operations Company, effective on September 25, 2018, is suspended until January 24, 2019.
