

Please find the enclosed substitute sewer tariff sheet 11B for filing with the Missouri Public Service Commission (Commission) on behalf of Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers). On March 12, 2021, Confluence Rivers filed revised water and sewer tariff sheets pursuant to the Commission's *Order Approving Acquisition Of Water And Sewer Assets And Granting Certificates Of Convenience And Necessity* issued in Case No. WM-2020-0282.¹ The sewer tariff sheets were assigned Tracking No. YS-2021-0168. Each of the revised tariff sheets were to have an issue date of March 12, 2021, and a proposed effective date of April 11, 2021. (Confluence Rivers), please find in electronic format certain water and sewer tariff sheets (list attached). These tariff sheets are being filed pursuant to the Commission's *Order Approving Acquisition Of Water And Sewer Assets And Granting Certificates Of Convenience And Necessity* issued in Case No. WM-2020-0282.


