ORDER RECOGNIZING NAME CHANGE AND APPROVING TARIFF

On April 5, 2012, TelCove Operations Inc. (“Company”) filed notification of its change of corporate name to “TelCove Operations, LLC” and revised tariff sheets reflecting the name change. Substitute tariff sheets were filed on April 9, 2012. The tariffs have an effective date of April 15, 2012.

The Staff of the Missouri Public Service Commission filed a verified recommendation on April 11, 2012. Staff recommends that the Commission recognize the new name. Staff states that the Company’s application complies with the filing requirements in Rule 4 CSR 240-2.060, no entities intervened to oppose the name change, the Company is not delinquent in any required filings with the Commission, and the filed tariff adoption notices are compliant with Commission rules.

The Commission has reviewed the application and Staff's recommendation. The Commission finds that the name change shall be recognized and the revised tariff sheets shall be approved.
