**ORDER APPROVING TARIFF SHEETS IN COMPLIANCE
WITH COMMISSION ORDER**

Issue Date: June 16, 2022

Effective Date: July 2, 2022

On April 6, 2022, the Commission issued its Report and Order in The Empire District Electric Company d/b/a Liberty’s (Empire) general rate proceeding. The Report and Order authorized Empire to file compliance tariff sheets to implement the Report and Order’s terms. On May 17, 2022, the Commission approved compliance tariff sheets filed by Empire. On June 2, 2022, Empire filed additional Tariff Revision YE-2022-0270, with an effective date of July 2, 2022, to further comply with the Report and Order. Empire explains that these additional tariff sheets were inadvertently not included in Empire’s previous compliance tariff filing.

The Commission ordered its Staff to file a recommendation about the compliance tariff sheets by June 15, 2022. Other parties were also given until that date to file any comments concerning the compliance tariff sheets. Staff timely recommended the Commission approve the compliance tariff sheets. No other comments were received.

After reviewing the compliance tariff sheets and Staff’s recommendation, the Commission finds the tariff sheets comply with the Commission’s Report and Order. So that Empire can implement the compliance tariff sheets on their effective date, the Commission finds it reasonable to make this order effective in less than thirty days.

THE COMMISSION ORDERS THAT:

1. Empire's following compliance tariff sheets, Tracking No. YE-2022-0270, are approved to become effective on and after July 2, 2022:
