The accompanying substitute tariff sheet issued by Union Electric Company d/b/a Ameren Missouri (Ameren Missouri or Company), is being transmitted for filing to replace the substitute 6<sup>th</sup> Revised Sheet No. 73.11 filed on April 6, 2017, which itself replaced a tariff sheet with the same designation that was filed March 23, 2017. As noted in the April 6 filing, the first substitution occurred to correct a typographical error in the March 23 version.

The Company is filing this second substitute tariff sheet to remove provisions that were formerly necessary to address the \$0.00200/kWh cap that had been applicable to the former Industrial Aluminum Smelter (IAS) class. The IAS class was eliminated effective April 1, 2017 when new base rate schedules took effect as a result of the resolution of File No. ER-2016-0179. The Fuel Adjustment Rates (FARs) reflected in this second substitute tariff sheet are the same as those filed on March 23, 2017 and in the first substitute tariff sheet filed April 6, 2017.
