ORDER APPROVING COMPLIANCE TARIFF SHEETS

Issue Date: August 10, 2016

Effective Date: August 19, 2016

On July 12, 2016, the Commission issued a report and order that rejected Hillcrest Utility Operating Company's ("Hillcrest") tariffs to increase the company's annual revenues for its provision of water and sewer service. However, the Commission authorized Hillcrest to file new tariff sheets sufficient to recover revenues as determined in that report and order. Hillcrest filed its compliance tariff sheets on July 20, 2016, to become effective on August 19, 2016.

The report and order directed the Commission's Staff to file a recommendation regarding Hillcrest's compliance tariff sheets by July 27, 2016 and directed any other party wishing to file a recommendation regarding the compliance tariff sheets to do so no later than July 27, 2016.

On July 27, 2016, the Commission's Staff filed its recommendation, which concluded the tariff sheets comply with the Commission's report and order and recommends the Commission approve the compliance tariff sheets to be effective on August 19, 2016. No other party filed a recommendation or response.

The Commission has reviewed the proposed tariff sheets and Staff's recommendation. The Commission independently concludes that the submitted compliance tariff sheets are consistent with the Commission's report and order, so the Commission will approve Hillcrest's tariff sheets to become effective for service rendered on and after August 19, 2016.

THE COMMISSION ORDERS THAT:

1. The proposed water service tariff sheets submitted under Tariff Tracking No. YW-2017-0015, by Hillcrest Utility Operating Company, are approved effective on and after August 19, 2016. The specific tariff sheets approved are:

Original Sheet No. 1 through Original Sheet No. 36

2. The proposed sewer service tariff sheets submitted under Tariff Tracking No. YS-2017-0016, by Hillcrest Utility Operating Company, are approved effective on and after August 19, 2016. The specific tariff sheets approved are:

P.S.C. MO No. 4, canceling P.S.C. MO No. 2

Original Sheet No. 1 through Original Sheet No. 36
