ORDER CANCELING CERTIFICATE
AND ACCOMPANYING TARIFFS

Issue Date: July 17, 2007

Effective Date: July 27, 2007

On May 29, 2007, ALLTELL Communications, Inc. filed a motion asking the Commission to cancel their certificate of service authority and accompanying tariffs. ALLTEL has been authorized to provide basic local exchange telecommunications services by the Commission.

In Case Number TA-99-298, the Commission granted ALLTEL a certificate to provide basic local exchange telecommunications services. ALLTEL's tariffs, PSC MO No. 2, and PSC MO No. 3, were also approved.

On June 7, 2007, the Staff of the Missouri Public Service Commission filed its recommendation. Staff indicated that because the company requested cancellation of its certificate and tariffs and because the company is no longer providing telecommunication services in Missouri, Staff recommends that the Commission issue an order canceling ALLTEL's certificate and tariffs.

ALLTEL indicates it has no overdue annual reports or assessments and no pending action or unsatisfied final judgments or decisions against it in any courts

which involve customer service or rates, which action, judgment or decision occurred in the last three (3) years.

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo, which states, in part, “[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

Having reviewed ALLTEL’s motion and Staff’s Recommendation, the Commission finds that the certificate of service authority and accompanying tariffs granted to ALLTEL Communications, Inc. shall be canceled.

IT IS ORDERED THAT:

1. The certificate of service authority to provide basic local exchange telecommunications services, granted to ALLTEL Communications, Inc., in Case Number TA-99-298, is canceled.
2. ALLTEL Communications, Inc.’s tariff, PSC MO. No. 2, is canceled.
3. ALLTEL Communications, Inc.’s tariff, P.S.C. MO. No. 3, is canceled.
4. This order shall become effective on July 27, 2007.
5. This case may be closed on July 28, 2007.
