Pursuant to 20 CSR 4240-28.011(2), Northeast Missouri Rural Telephone Company, respectfully requests that the Missouri Public Service Commission (“Commission”) acknowledge its adoption of the NEMR Telecom fictitious name. Northeast Missouri Rural Telephone Company is in good standing with the Missouri Secretary of State, in compliance with the Commission’s Annual Report requirements, and current with its Missouri USF and Commission assessments. The company has reviewed its contacts on the Commission’s electronic filing and information system (EFIS) and they have been updated as needed.

Evidence of the fictitious name registration of NEMR Telecom is included as Attachment A. Copies of the adoption notice and revised tariff title sheets (ILEC and IXC) that are being filed concurrently with this notice (with ten-day effective dates) reflecting the new name are included as Attachment B.

Also, please note that Northeast Missouri Rural Telephone Company was issued a CLEC certificate in Case No. CA-2021-0122 and an IVoIP Registration in Case No. DA-2020-0413 and will also be using the NEMR Telecom fictitious name for its CLEC and IVoIP services.
