### ORDER APPROVING TARIFF

On July 20, 2018<sup>1</sup>, Missouri-American Water Company ("MAWC") filed tariff sheets, effective August 19, to allow it to provide water service in the City of Lawson, Missouri. MAWC filed the tariff as ordered by the Commission on July 19. MAWC filed substitute tariff sheets on July 26.

The Commission ordered its Staff to file a recommendation no later than August 8. Staff filed its Recommendation on August 7, advising the Commission to approve the submitted tariff filing.

The Commission has authority to approve tariff sheets pursuant to Sections 393.140(11) and 393.150, RSMo. The Commission has reviewed the tariff sheets and Staff's recommendation. The Commission finds that the tariff sheets conform to the Commission's order granting MAWC the certificate of convenience and necessity. Thus, the Commission will approve the tariff sheets.
