**RE: Notice of Fidelity Telephone Company and Fidelity Communications Services I, Inc.
to Partially Detariff Pursuant to Section 392.461, RSMo. and 4 CSR 240-28.070(6).**

Dear Secretary Woodruff:

Section 392.461, RSMo. allows telecommunications companies, upon notice to the Commission, to elect to be partially exempt from the requirement that they offer retail services to residential or business end users through tariff, and to withdraw such tariffs.

Pursuant to 4 CSR 240-28.070(6), Fidelity Telephone Company (FTC) and Fidelity Communications Services I, Inc. (FCSI) hereby provide notice of their elections to be partially exempt from tariff filing requirements for late payment charge, returned check charge, pay by phone convenience fee, and non-recurring service connect charges effective May 8, 2017.
