ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: December 29, 2006 Effective Date: January 8, 2007

On December 18, 2006, the Staff of the Missouri Public Service Commission filed a motion asking the Commission to cancel the certificate of service authority and tariff of Infonet Telecommunications Corporation (Infonet), a company that has been authorized by the Commission to offer intrastate interexchange telecommunication service in Missouri, as well as non-switched local exchange telecommunication services limited to providing dedicated private line services. Staff also asks the Commission to cancel the tariff associated with that certificate.

In Case Number TA-2002-459, the Commission granted Infonet a certificate of service authority to provide intrastate interexchange telecommunication service, as well as non-switched local exchange telecommunication services limited to providing dedicated private line services. Infonet's tariff, PSC Mo. No. 1, was approved in the same case.

Through a letter from Infonet's agent, Infonet requests the Commission cancel its certificate and tariff because it has no customers using the service that was to be provided under that name, and does not intend to pursue that line of business. No

complaints against Infonet have been submitted since the commencement of the Electronic Filing and Information System and the company does not have any overdue annual reports or assessment fees.

Staff recommends that the Commission cancel the company's certificate of service authority to provide intrastate interexchange telecommunications service, as well as non-switched local exchange telecommunication services limited to providing dedicated private line services and its accompanying tariff.

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion and Infonet's request, the Commission finds that the certificate of service authority and accompanying tariff granted to Infonet shall be canceled.

IT IS ORDERED THAT:

- 1. The certificate of service authority to provide intrastate interexchange telecommunications service, as well as non-switched local exchange telecommunication services limited to providing dedicated private line services, granted to Infonet Telecommunications Corporation, in Case Number TA-2002-459, is canceled.
- 2. Infonet Telecommunications Corporation's tariff, P.S.C. Mo. No. 1, is canceled.
 - 3. This order shall become effective on January 8, 2007.

4. This case may be closed on January 9, 2007.
