**Re: Notice of Election to Be Exempt from Certain Tariff Filing
Requirements Pursuant to Section 392.461, RSMo. – Green Hills
Telecommunications Services**

Dear Mr. Woodruff:

Section 392.461, RSMo., allows Telecommunications Companies, upon notice to the Missouri Public Service Commission (“Commission”) to elect to be exempt from certain tariff filing requirements, including the tariffing of rates for retail telecommunications services provided to end-user customers. Accordingly, Green Hills Telecommunications Services hereby provides notice of its election to be exempt from tariff filing requirements and of its intent to withdraw the retail rates for residential and business packaged services from its tariff effective January 1, 2016.

In furtherance of this election, Green Hills Telecommunications Services is filing the following revised tariff sheets to withdraw the rates for its packaged services:

- Section 28, Third Revised Sheet 12, Cancelling Second Revised Sheet 12
- Section 28, Third Revised Sheet 13, Cancelling Second Revised Sheet 13
- Section 28, Second Revised Sheet 14, Cancelling First Sheet 14

Coincident with the withdrawal of its tariffed rates for packaged services, Green Hills Telecommunications Services is publishing the prices for its packaged services on its website as follows: <https://www.greenhills.net>.


