Attached for electronic filing are revisions to the P.S.C. MO. No. 1 General and Local Exchange Tariff for CenturyTel of Missouri, LLC d/b/a CenturyLink. These revisions are filed in accordance with Missouri Public Service Commission Rules and Regulations and electronically submitted with an April 28, 2014 issue date and a proposed effective date of April 29, 2014. The following revisions are included with this filing:

This filing introduces two new bundle options for business customers. Core Connect 2 and Core Connect 2 LITE will share the regulations previously tariffed for Core Connect and Core Connect LITE. Those bundles are being renamed "Core Connect 1" and "Core Connect 1 LITE" and the CORE CONNECT regulations will apply for the existing and the new bundles. Consequently, a number of regulations are moved to different pages and are being revised to accommodate multiple bundle options. These revisions do not impact current customers or the manner in which their services will continue to be provided.

The most notable revision is the removal of the discount table in conjunction with term plans. The rate table has been expanded to include the applicable discounts in the monthly rates. This simplified change in presentation does not result in any rate or discount changes for customers who are already subscribed to a Core Connect bundle under a term plan.

Also under this filing, an existing promotional offer is being revised and extended while another is being introduced for business customers who are not subscribed to the Company's High Speed Internet service, when they subscribe to Core Connect 2 or Core Connect 2 LITE.

During the period **April 29, 2014** through **December 31, 2014**, business Core Connect **2 and Core Connect 2 LITE** customers may be eligible for a waiver of all nonrecurring charges (excluding charges applicable for inside wiring, construction, or CPE installation) lines that are otherwise applicable when they order additional Core Connect packages. To be eligible, customers who are contacted by the Company or who contact the Company and request this promotion must subscribe to an additional Core Connect **2 or Core Connect 2 LITE** package under a term discount plan. The additional line(s), up to a maximum of nine, may be at the same or different locations but must be billed under the same account. This promotional offer may not be combined with other discounts unless otherwise specified. (C)

ao. Simple Choice Unlimited \$10 for 24 w/PRISM Promotion

During the period November 2, 2012 through December 31, 2014, residential customers may be eligible for a \$10 bill credit for 24 months. To be eligible, customers who are contacted by the Company or contact the Company and request this promotion must be a new subscriber or a current subscriber to the Company's Simple Choice Unlimited local package, and must be a new subscriber to the Company's non-regulated PRISM video service, and must agree to maintain both the Company's qualifying local package, and the Company's PRISM video service for a minimum of 12 months.

The initial bill credit will be reflected on the customer's first or second invoice following the customer's acceptance of this offer and will continue for 23 consecutive months thereafter. If a customer discontinues any of the qualifiers prior to the end of the 24 month period, no additional credits will be applied.

In no event will the application of this discount be used in conjunction with any other credits to take the customer's billed amount below zero.

ap. Simple Choice ULD with HSI Discount

During the period May 1, 2013 through September 30, 2013, residence customers who subscribe to Simple Choice Unlimited will receive a \$5.00 discount when they also subscribe to the Company's High Speed Internet.

aq. Core Connect 2 MRC Discount

From April 29, 2014 through December 31, 2014, business customers who are not currently subscribed to the Company's High Speed Internet (HSI) service may be eligible for a discount when they subscribe to HSI with Core Connect 2 or Core Connect 2 LITE bundles. To receive the discount, customers must subscribe to Core Connect 2 or Core Connect 2 LITE under a two or three-year term discount plan (TDP).

Eligible customers will receive a \$10 monthly discount on the Core Connect 2 initial bundle rate or a \$15 monthly discount on the Core Connect 2 LITE initial bundle rate, for the first twelve months of a two or three-year TDP. Eligible customers will also receive a \$5 monthly discount on the Core 2 or Core 2 LITE additional bundle rate for the first twelve months of a two or three-year TDP.

If a customer discontinues any of the required services during the first year of the TDP, the discounts applied under this promotion will be rescinded and charges will be reflected on the customer's next or final bill in addition to other applicable early termination liability charges.

The benefits awarded under this promotion may not be combined with the benefits of other currently available promotions.

C. Term Discount Plan

1. A Term Discount Plan (TDP) provides customers with discounts when the customer subscribes to CORE CONNECT under a one, two or three-year term agreement.
2. Any CORE CONNECT line(s) added subsequent to establishment of a TDP must be added under a separate TDP commitment period.
3. The rates and discounts in effect when customers subscribe to CORE CONNECT under a TDP will apply until expiration of that TDP. CORE CONNECT lines that are subsequently added under a separate TDP will receive the tariffed **rates in effect** when those lines are added. (T)
4. Upon expiration of a TDP, the TDP discounts specified in **E.** following will expire, and the customer will be charged at the then prevailing **month-to-month** rate. If the customer renews the TDP or signs up for a new TDP, the tariffed **rates then** in effect will apply for the new or renewed TDP. (T)

If the Company terminates service for cause or if the customer discontinues the service in whole or in part without cause prior to the expiration date, no termination liability charges will apply for the regulated portion(s) of CORE CONNECT. However, if customers remove any of the qualifying services prior to the TDP expiration date, the remaining components of CORE CONNECT will be converted to ala carte rates and the TDP discount will not apply.
