On September 29, 2021,¹ the Commission issued an Order Granting Certificate of Convenience and Necessity ("CCN") which, in part, ordered Mid Mo Sanitation LLC (Mid Mo) to submit newly created and/or revised tariff sheets that included an updated map and legal description to reflect its authority to operate its sewer system in the land application area for which the order granted a certificate of convenience and necessity (Order). On October 7, Mid Mo filed Tariff Revision YS-2022-0074 with a November 6 effective date. On October 8, the Commission ordered the Commission's Staff (Staff) to file a recommendation. On October 15, the Staff filed its Recommendation on Compliance Tariff. Staff states it has reviewed the tariff and concluded that it includes an accurate updated map and legal description of the area set out in Attachments A and B of Staff's Memorandum. Staff recommends the Commission issue an order approving the tariff. The Commission will do so.

THE COMMISSION ORDERS THAT:

1. Tariff Revision YS-2022-0073 filed on October 7, 2021, is approved to become effective on November 6, 2021.
