The tariff sheets listed below issued by Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri" or "the Company") are being filed concurrently with this letter as a revision of Schedule No. 6, Schedule of Rates for Electricity, as follows:

These tariff sheets bear in issue date of August 23, 2019 and a 30-day effective date of September 22, 2019.

The revised sheets are being filed after consultation with the Staff in order to provide for recovery of eligible Renewable Energy Standard ("RES") compliance costs and return of the RES benefits covered by the Company's Renewable Energy Standard Rate Adjustment Mechanism ("RESRAM") on a calendar month basis instead of on a billing month basis.

The Company is filing the tariff sheet revisions at this time so that this change can become effective prior to the due date of its first RESRAM rate adjustment filing which without the change is due September 26, 2019 and, with the change, would be October 1, 2019.
