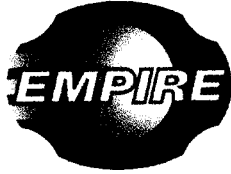

On behalf of The Empire District Gas Company (EDG), I am providing herewith to the Missouri Public Service Commission (Commission) for filing in electronic form as P.S.C. Mo. No. 2, all tariff sheets consisting of original gas rate schedules and original gas rules and regulations, which are designed to cancel P.S.C. Mo. No. 1 in its entirety. This filing eliminates all of the references to the prior owner of the gas property, Aquila, Inc., and inserts the name and appropriate references to the current owner, EDG. In addition this filing includes a general clean up of minor typographical errors that EDG and the Staff of the Public Service Commission ("Staff") have found in the P.S.C. Mo. No. 1 since the property was acquired on June 1, 2006. The minor typographical changes have all been previously discussed with the Staff.
