## ORDER APPROVING DISPOSITION AGREEMENT AND TARIFF

Issue Date: October 21, 2009

Effective Date: October 27, 2009

The Missouri Public Service Commission is approving the disposition agreement entered into between the Commission's staff ("Staff") and I.H. Utilities, Inc., ("the company"), and unopposed by the Office of the Public Counsel ("OPC"). The Commission is also approving the associated tariff sheets ("tariffs") increasing rates for the company's water services. Such services supply approximately 700 residential customers in the Indian Hills subdivision in Crawford County.

On August 25, 2006, the company initiated a small company rate increase action. On August 3, 2009, Staff filed a Company/Staff Agreement Regarding Disposition of Small Water Company Revenue Increase Request ("disposition agreement") and tariffs. The Commission received a substitute page on August 10, 2009. Staff and the company signed the disposition agreement. OPC did not sign the disposition agreement.

On August 14, 2009, the Commission suspended the tariffs. Suspending the tariffs initiated a contested case procedure. Contested case procedure provides for waiver of an

evidentiary hearing<sup>3</sup> and other procedural formalities<sup>4</sup> by stipulation, agreement, and settlement.<sup>5</sup> The disposition agreement constitutes such an informal resolution because it proposes to fully dispose of all issues pertaining to the company's request.

On October 6, 2009, the Commission convened a local public hearing on the disposition agreement and tariffs. On October 13, 2009, Staff filed a statement of no change in Staff's position. On October 16, 2009, any request for an evidentiary hearing from OPC was due. OPC filed no request for an evidentiary hearing. On that date, OPC filed a statement of no opposition to the disposition agreement. Because all parties have either joined in the disposition agreement, or stated no opposition to it, they have waived further procedural formalities, including an evidentiary hearing.<sup>6</sup>

Based on the Commission's examination of the disposition agreement, the verified documents, and other evidence on file in this action, the Commission independently finds and concludes that the disposition agreement is in the public interest, and that the tariffs set rates that are just and reasonable. Therefore, the Commission will approve, and direct the company to comply with, the disposition agreement and tariffs. The Commission will also incorporate the disposition agreement into this decision as if set forth at length.

## THE COMMISSION ORDERS THAT:

The Company/Staff Agreement Regarding Disposition of Small Water
 Company Revenue Increase Request is approved and incorporated into this decision as if set forth at length.
