ORDER RECOGNIZING NAME CHANGE

On July 28, 2017, Laclede Gas Company and Laclede Gas Company d/b/a Missouri Gas Energy filed notice of their intent to change their name to Spire Missouri Inc. d/b/a Spire. They also filed the revised tariff sheets and adoption notices needed for Spire to adopt the current tariffs of Laclede and MGE. The Staff of the Commission responded on August 16, indicating the companies have complied with all statutory and regulatory requirements for changing their names. Staff recommends the Commission recognize the name change and approve the tariff changes. The Commission will do so.

THE COMMISSION ORDERS THAT:

1. The Commission recognizes the name change of Laclede Gas Company and Laclede Gas Company d/b/a Missouri Gas Energy to Spire Missouri Inc. d/b/a Spire.
2. The proposed tariff sheets submitted under Tariff Nos. JG-2018-0012 and JG-2018-0013 by Spire Missouri Inc. d/b/a Spire are approved, effective on and after August 30, 2017. The specific tariff sheets approved are:
