### **STAFF RECOMMENDATION**

**COMES NOW** the Staff of the Missouri Public Service Commission (Staff), by and through Staff counsel, and for its Recommendation, states as follows:

1. On February 7, 2011, Atmos Energy Corporation (Atmos or Company) filed a tariff sheet containing Atmos' Infrastructure System Replacement Surcharge (ISRS) rates in response to the Commission's February 4<sup>th</sup> Order Approving Infrastructure System Replacement Surcharge (Order). Atmos has requested a proposed tariff effective date of February 14, 2011, to coincide with the Company's next billing cycle in February.

2. Based on Staff's review of Atmos' tariff sheet, and for reasons stated in Staff's Memorandum, attached hereto as Appendix A and incorporated herein by reference, the Staff's analysis shows that Atmos' tariff sheet is in compliance with the Commission's February 4th Order. Staff is not opposed to Atmos' Motion for Expedited Treatment.

**WHEREFORE,** for the reasons stated above, the Staff recommends that the Commission issue an order allowing Atmos' tariff filing YG-2011-0398 to go into effect on February 14, 2011, as requested by Atmos.
