ORDER APPROVING SECOND QUARTERLY COST ADJUSTMENT TARIFF

Issue Date: August 12, 2022

Effective Date: September 1, 2022

The Missouri Public Service Commission is approving the pending tariff sheet, which sets forth the quarterly cost adjustment (“QCA”) for Evergy Missouri West, Inc. d/b/a Evergy Missouri West (EMW) in calendar year 2022, second quarter. EMW filed the tariff sheet on July 15, 2022, with an effective date of September 1, 2022.

The Staff of the Commission (Staff) filed its recommendation on July 26, 2022, stating that the tariff sheet meets the requirements of EMW’s tariff sheets 6.6 through 6.10. Staff recommends the Commission approve the pending tariff sheet. Greater than ten days have passed and the Commission received no response to Staff’s recommendation.¹ No other comments on EMW’s tariff sheet have been received by the Commission.

The Commission concludes that the tariff complies with EMW’s tariff sheets 6.6 through 6.10, and will support safe and adequate service at just and reasonable rates. The Commission will approve the tariff.

As the application is unopposed, and so that this tariff may go into effect expeditiously on the requested effective date, the Commission will make this order effective in less than 30 days.
