Dear Judge Woodruff:

On July 7, 2022, The Empire District Gas Company d/b/a Liberty ("EDG") submitted certain tariff sheets consisting of revised and original rate schedules to comply with the Commission's *Report and Order* issued June 23, 2022, and effective July 3, 2022. Since this original submission, the Staff of the Commission identified certain matters in need of correction. In this regard, EDG is submitting substitutes for two sheets filed on July 7, is withdrawing three sheets which were filed on July 7, and is submitting three new revised sheets.

Attached hereto for filing are substitutes for (1) sheet RR 2, Rules and Regulations Index, to remove reference to 9.09 and (2) sheet 34, Transportation Rates, to remove reference to refunds. As substitutes, these sheets continue to bear an issue date of July 7, 2022, and an effective date thirty days thereafter (August 6, 2022). Redlined changes are being provided to the parties.

EDG is withdrawing the following revised tariff sheets which were submitted by EDG on July 7, 2022, as no changes need to take effect on these sheets in order to implement the terms of the *Report and Order*: (1) sheet 56, PGA Clause; (2) sheet 57, PGA Clause; and (3) sheet 32, Pipeline Capacity.

Lastly, EDG is submitting revised tariff sheet numbers 62 (PGA-South System), 63 (PGA-North System), and 65 (PGA-Northwest System), in order to reflect removal of the line for refund rates. This change is appropriate, because the refund provision is being removed from other tariff sheets in conjunction with implementation of the *Report and Order*. The refund rate provided for on these sheets is currently \$0.0 for each rate district, so there will be no impact to customers or billing as result of these three revised tariff sheets. Redlined changes are being provided to the parties. These three revised sheets bear an issue date of July 14, 2022, and a requested effective date thirty days thereafter (August 13, 2022).
