### ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: January 3, 2007 Effective Date: January 13, 2007 On December 18, 2006, the Staff of the Missouri Public Service Commission filed a motion asking the Commission to cancel the certificate of service authority and accompanying tariff of CCCMO Inc. d/b/a Connect! to provide basic local and local exchange telecommunication service in Missouri.

In Case Number TA-2000-199, the Commission granted CCCMO a certificate of service authority to provide basic local and local exchange telecommunication service. CCCMO's tariff, P.S.C. Tariff No. 1, was approved in the same case.

Through a letter from CCCMO's president, CCCMO requests the Commission cancel its certificate and tariff because it has no customers using the service that was to be provided under that name, and does not intend to pursue that line of business. All formal complaints against CCCMO have been resolved and it does not have any overdue annual reports or assessment fees. In addition, according to the Office of the Missouri Secretary of State, CCCMO was dissolved on August 29, 2006.

Staff recommends that the Commission cancel the company's certificate of service authority to provide basic local and local exchange telecommunications service and its accompanying tariff.

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion and CCCMO's request, the Commission finds that the certificate of service authority and accompanying tariff granted to CCCMO shall be canceled.

#### IT IS ORDERED THAT:

1. The certificate of service authority to provide basic local and local exchange telecommunications service, granted to CCCMO, Inc. d/b/a Connect!, in Case Number TA-2000-199, is canceled.

- 2. CCCMO's telecommunications tariff, P.S.C. Tariff No. 1, is canceled.
- 3. This order shall become effective on January 13, 2007.
- 4. This case may be closed on January 14, 2007.
