**ORDER APPROVING TARIFF IN COMPLIANCE  
WITH COMMISSION ORDER**

Issue Date: April 4, 2018

Effective Date: April 19, 2018

The Commission issued its *Amended Report and Order* on March 7, 2018, authorizing Spire Missouri Inc. to submit tariff sheets setting new rates. Spire Missouri filed its compliance tariffs (Tariff Nos. YG-2018-0117 and YG-2018-0118) on March 20, 2018, and substituted on March 30, 2018. The tariff sheets have an effective date of April 19, 2018.

The Commission issued an order directing the Staff of the Missouri Public Service Commission (Staff) to file a recommendation regarding the tariffs no later than March 29, 2018. The Commission also directed that any objections to the tariffs be filed on that date. The Commission later granted Staff an extension of time until April 2, 2018, to file its recommendation. That order also directed that any replies to Staff's recommendation or any other responses be filed no later than April 3, 2018, at 12:30 p.m.

On April 2, 2018, Staff recommended approval of Tariff Nos. YG-2018-0117 and YG-2018-0118, as substituted, to be effective April 19, 2018. Staff stated that it had examined the proposed tariff sheets and determined that they comply with the Commission's *Amended Report and Order*. Staff also noted that in addition to changes made in compliance with the Commission's order, certain tariff sheets were revised to "more accurately reflect Spire Missouri's current practices."<sup>1</sup>

The Commission finds that Spire Missouri's tariff sheets comply with the Commission's March 7, 2018 *Amended Report and Order* and will approve them.

**THE COMMISSION ORDERS THAT:**

1. The tariff sheets, bearing Tariff No. YG-2018-0117, filed on March 20, 2018, as substituted on March 30, 2018, by Spire Missouri Inc. for its Spire Missouri East service territory, are approved to become effective on April 19, 2018.
2. The tariff sheets, bearing Tariff No. YG-2018-0118, filed on March 20, 2018, as substituted on March 30, 2018, by Spire Missouri Inc. for its Spire Missouri West service territory, are approved to become effective on April 19, 2018.
3. This order shall become effective on April 19, 2018.
