Dear Mr. Reed:

Please extend the effective date from July 1, 2012, to July 3, 2012, for the access tariff concurrence sheets filed by BPS Telephone Company regarding PSC Mo. No. 1 (Tariff File No. YI-2012-0692) in Case No. TT-2012-0317.

Also, please extend the tariff cancellation letter regarding PSC Mo. No. 2 – Intrastate Access Services (Tariff File No. YI-2012-0691) to coincide with the July 3, 2012 extension above.

On May 2, 2012, the Company submitted tariff revisions proposing intrastate access reductions pursuant to the FCC's November 18, 2011 Report and Order and Further Notice of Proposed Rulemaking (Transformation Order) in WC Docket Nos. 10-90, etc. (FCC 11-161). The Transitional Intrastate Access Service reductions proposed in that filing comply with 47 C.F.R. §51.907(b).

On March 28<sup>th</sup>, 2012, the FCC released an Order granting a limited waiver of the July 1 effective date for the 2012 annual access filings, specifically including §51.907(b), and setting July 3, 2012 as the effective date for the 2012 rate changes required by its Transformation Order (See Para. 15 of DA 12-482, released on March 28, 2012). Accordingly, the Company hereby extends the effective date of its intrastate rate reductions as well as the cancellation of its PSC Mo. No. 2 to mirror the effective date of the interstate rate changes.
