**ORDER APPROVING TARIFF TO ADJUST  
PACC ADJUSTMENT RATES**

Issue Date: June 9, 2022

Effective Date: June 19, 2022

On February 1, 2022,<sup>1</sup> Vicinity Energy, Kansas City, Inc. (Vicinity) filed tariff sheets (Tariff No. YH-2022-0218) to change Vicinity's production adjustment cost clause (PACC) rates for steam service. On March 24, the Commission issued an order rejecting the proposed tariff revision and suspending the timeline for approval of Vicinity's PACC Tariff filing. That order also directed Vicinity to file substitute tariff sheets to return a \$731,938 regulatory liability to its customers.

On May 20, Vicinity filed revised tariff sheets (Tariff No. YH-2022-0260) to replace its original tariff filing, and on May 23, filed substitute tariff sheets to be considered in place of the May 20 version. On May 25, Staff filed its recommendation to reject the tariff sheets Vicinity filed May 20 because they bear incorrect issue and effective dates, and approve the proposed substitute tariff sheets Vicinity filed May 23, to go into effect June 19.

The Commission has reviewed Vicinity's tariff sheets and Staff's verified recommendation. Based on these filings, the Commission finds that the tariff sheets are

in compliance with the Commission's previous orders and Vicinity's current tariff provisions and should be approved.

So that this order can be effective at the same time as the tariff sheets being approved, the Commission finds it reasonable to make this order effective in less than thirty days.

**THE COMMISSION ORDERS THAT:**

1. Tariff No. YH-2022-0260, as substituted on May 23, is approved to become effective June 19, 2022. The tariff sheets approved are:
