**ORDER RECOGNIZING NAME CHANGE**

Holway Telephone Company, Holway Long Distance, KLM Telephone Company, KLM Long Distance, and N.W. Communications Co., all currently doing business as American Broadband, submitted a letter on August 11, 2022, advising that they have adopted the fictitious name of Fastwyre Broadband. On August 26, 2022, the Commission’s Staff filed a recommendation indicating the companies have complied with all statutory and regulatory requirements for changing their name. Staff recommends the Commission recognize the name change. Staff also recommends that the tariff changes to adopt the new name filed by Holway Telephone Company, Holway Long Distance Company, KLM Telephone Company, and KLM Long Distance Company be approved, or allowed to take effect by operation of law. The Commission will recognize the name change and will allow the submitted tariffs to take effect by operation of law.

**THE COMMISSION ORDERS THAT:**

1. The Commission recognizes Holway Telephone Company d/b/a American Broadband's name change to Holway Telephone Company d/b/a Fastwyre Broadband.
2. The Commission recognizes Holway Long Distance d/b/a American Broadband's name change to Holway Long Distance d/b/a Fastwyre Broadband.
3. The Commission recognizes KLM Telephone Company d/b/a American Broadband's name change to KLM Telephone Company d/b/a Fastwyre Broadband.
4. The Commission recognizes KLM Long Distance d/b/a American Broadband's name change to KLM Long Distance d/b/a Fastwyre Broadband.
5. The Commission recognizes N.W. Communications Co. d/b/a American Broadband's name change to N.W. Communications Co. d/b/a Fastwyre Broadband.
6. This order shall be effective on September 28, 2022.
7. This file shall be closed on September 29, 2022.
