On April 28, 2004, the Joint CLECs¹ petitioned the Commission to investigate why Southwestern Bell Telephone, L.P., d/b/a SBC Texas (SBC Texas) and Sage Telecom, Inc. (Sage) had not filed the agreement announced between their companies in April for review and approval with the Commission, to require SBC Texas and/or Sage to file the Agreement, and to do so on an expedited basis.² SBC Texas responded on May 6, 2004, arguing that the SBC-Sage Agreement was partly a private, commercially sensitive arrangement that they did not intend to file, and partly an amendment to SBC Texas and Sage's existing section 251 interconnection agreement.³ Sage has provided arguments in this docket supporting SBC's position.⁴

On May 13, 2004, the undersigned ALJ, acting pursuant to authority expressly delegated by the Commission, ordered SBC Texas and Sage to provide four copies of the agreement that SBC Texas and Sage had announced in April 2004, later clarifying that this order included "any agreements entered into within the last two months that are related to the SBC-Sage Agreement. This includes any understandings, oral agreements or side agreements that may have a bearing on the SBC-Sage

Agreement; put another way, it includes any agreements that impact the interconnection relationship between SBC Texas and Sage."⁵

SBC Texas and Sage provided complete, unredacted copies of their Local Wholesale Complete Agreement (SBC-Sage Agreement) for *in camera* review by Commission personnel, along with declarations explaining "the reasons supporting SBC's and Sage's claim that specific Agreement terms are exempt from public disclosure under the Public Information Act and subject to treatment as protected materials."⁶

At its May 27, 2004, open meeting, the Commission determined that the SBC-Sage Agreement is, in its entirety, a negotiated interconnection agreement that is subject to the terms of the Federal Telecommunications Act (FTA). The Commission further determined that the SBC-Sage Agreement shall be publicly filed in a new docket with this Commission by June 21, 2004, pursuant to the terms of P.U.C. PROC. R. 21.97 (Approval of Negotiated Agreements). The Commission delegated authority to the undersigned ALJ to issue an order consistent with the Commission's decision.

Pursuant to the delegated authority described above, the undersigned ALJ directs SBC Texas and Sage to publicly file the complete, unredacted SBC-Sage Agreement⁷ that was previously provided to the Commission for *in camera* review, and to do so on or before June 21, 2004, by 3:00 p.m.
