Preferred Long Distance, Inc. dba Telplex Communications dba Telplex ("Telplex") submits to the Missouri Public Service Commission an electronic copy of amended sheet number 67 to Telplex's Missouri local exchange and interexchange tariff, Missouri P.S.C. Tariff No. 1, for incorporation into the Company's tariff.

With this submission, Telplex makes modest rate increases to its Easy Access and Remote Access Forward custom calling features that were not included in the custom calling rate feature rate amendments made in April. The Company also removes unregulated voice mail services from its Tariff. An August 15, 2016 effective date is requested, more than 30 days following the issue date.
