## CORRECTED ORDER APPROVING COMPLIANCE TARIFF SHEETS

Issue Date: December 1, 2011

Effective Date: December 15, 2011

The Missouri Public Service Commission is approving the tariff sheets (“compliance tariff sheets”) filed in compliance with the Commission’s order effective August 20, 2011 (“order”).

Algonquin Water Resources of Missouri, LLC filed the compliance tariff sheets.<sup>1</sup> Staff filed its recommendation favoring approval of the compliance tariff sheets as conforming to the order.<sup>2</sup> No hearing is necessary before approving the compliance tariff sheets,<sup>3</sup> so this action is not a contested case, and the Commission need not separately state its findings of fact.

Based on the statements in the file, the Commission independently finds and concludes that the compliance tariff sheets support safe and adequate service at just and reasonable rates, so the Commission will approve the compliance tariff sheets.
