APPLICATION OF MERCURY WIRELESS KANSAS, LLC

Mercury Wireless Kansas, LLC ("Mercury Wireless" the "Company" or "Applicant"), respectfully submits this Application for Designation as an Eligible Telecommunications Carrier ("ETC") pursuant to Section 214(e)(2) of the Communications Act of 1934, as amended (the "Act"), Section 54.201 et seq. of the Rules of the Federal Communications Commission ("FCC"), and the Missouri Code of State Regulations ("CSR") Title 4, Sections 240-2.060 and 240-31.130.

Mercury Wireless requests that the Missouri Public Service Commission ("Commission") grant it designation as an ETC in the state of Missouri for the purpose of receiving federal universal service support funds, under the broadband initiative commonly known as Connect America Fund II (CAF II), in the geographic areas specified in this Application and under the FCC's Lifeline program for low income consumers. Applicant does not intend to seek funding under the Missouri Universal Service Fund.

As discussed in more detail below, Mercury Wireless meets the statutory and regulatory requirements for designation as an ETC and will be able and prepared to offer high-cost supported services and related Lifeline services throughout its designated service area in Missouri. Granting ETC status to Mercury Wireless will benefit the public interest by making the Company's services available to a broad range of consumers at an affordable cost. Because the availability of Mercury Wireless' services so clearly serves the interests of Missouri consumers, as more fully discussed

herein, Mercury Wireless respectfully requests that the Commission grant this Application as quickly as possible.

In support of this Application, Mercury Wireless provides the following information:

L OVERVIEW OF APPLICANT (4 CSR 240-31.130(1)(A) and .4 CSR 240-2.060).

1. Mercury Wireless is an Indiana limited liability company and has filed for authority to conduct business in Missouri, with principal offices at 3301 S. Kansas Ave., Topeka, Kansas 66611. Applicant will promptly submit its Certificate of Good Standing, as **Exhibit "A"** to this Application when it becomes available. Other primary contact information is as follows:

2. Mercury Wireless will provide fixed wireless iVOIP and broadband service over a very stable network that will provide customers in its service territory access to phone and high-speed internet service at an affordable rate. Mercury Wireless strives to ensure high quality service and customer service. Mercury Wireless does not currently provide service in any area in Missouri but has just filed registration as an iVOIP provider.

4. Mercury Wireless has no pending action or final, unsatisfied judgments or decisions against it from any state or federal agency or court which involve customer service or rates, which have occurred within the past three (3) years.

5. Mercury Wireless does not have Missouri annual report or assessment fees that are overdue.

II. MERCURY WIRELESS SATISFIES THE COMMISSION'S AND THE FCC'S REQUIREMENTS FOR ETC DESIGNATION FOR VOICE TELEPHONY SERVICE (4 CSR 240-31.130(1)(B) and 47 CFR 54.201).

1. Mercury Wireless will provide fixed wireless iVOIP telephony services and related services, including: residential and business broadband internet, unlimited residential and business digital phone, web hosting, email hosting, and custom network design. Mercury Wireless will make available Lifeline service, as defined in 47 CFR 54.401 and comply with all requirements of the Lifeline program under 47 CFR Part 54, Subpart E and all regulations of this Commission. Mercury Wireless' services will include low cost telephony services offered to customers that live in areas with poor cellular and broadband service. Such service will, in addition to improved accessibility and pricing, enable target customers access to reliable emergency call capability (i.e. fire, ambulance and police). Lifeline services will be offered at discounted rates based on the determination that the household is receiving other applicable government assistance.

2. Mercury Wireless initially proposes to provide iVOIP and broadband services in the geographical areas for which it has been provisionally selected to receive CAF II funds, identified in

Exhibit “B” attached hereto. Providing service to the rural areas within the Territory will improve the supply/demand gap that currently exists due to the ineffective coverage of other service providers.

3. In order to service the Territory, Mercury Wireless will utilize its own infrastructure. Mercury will employ CISCO routers, backhauls using both licensed and unlicensed spectrum, and licensed LTE and unlicensed 5GHz access points.

4. Mercury Wireless is seeking ETC designation to participate in CAF II, is not seeking ETC designation solely for Lifeline purposes, and therefore 4 CSR 240-31.130(1)(B)(3)(A-B) do not apply.

5. Mercury Wireless certifies it will utilize multiple advertising mediums, such as radio, newspaper, billboards and social media sites, to advertise the availability of its services, including its CAF II supported services and prices. Examples of recent advertising are attached hereto as **Exhibit “C”**. Mercury Wireless has not yet developed Lifeline advertising. Mercury Wireless will advertise the availability of its services and charges through media of general distribution in a manner reasonably designed to reach potential Lifeline consumers and make them aware of such offerings, as required by FCC rule 54.405(B) including by disclosing: Applicant’s name, that the service is Lifeline service, that it is a government assistance program, that the service is non-transferable, and that it is available only to eligible consumers and limited to one discount per household. Mercury Wireless does not intend to use direct mail campaigns. Applicant will conduct business solely under the name Mercury Wireless and will not use additional service or brand names without authorization from the Commission.

6. Mercury Wireless has the ability to remain functional in emergency situations,
to wit:

- a) 24-hour battery array used to avoid service interruption during power outage;
- b) Rerouting broadband to a downed site through a redundant link by using a separate fiber source rerouted by separate back haul systems that will be implemented on all tower systems. This provides backup in case main broadband delivery is down.
- c) Increase of bandwidth during emergency spikes.

7. Mercury Wireless certifies that it will, upon ETC status being granted, comply with the applicable service requirements of 47 CFR 54.201, as more fully described in this Section II. Mercury Wireless further certifies that all funding from the Lifeline program will flow through to Lifeline customers. Mercury Wireless will invest in the technological infrastructure required to maintain customer databases capable of differentiating customers participating in the Lifeline program. Mercury Wireless will use the required enrollment form. It will ensure subscribers meet eligibility requirements, confirm the accuracy of identities and addresses, and that only one discount is received per household. It will annually verify a customer's continued eligibility for the Lifeline program and require the customer to change to another form of service if they are no longer eligible. Mercury Wireless will provide service to qualifying Lifeline low-income customers at costs capped at the lesser of 10% of its cost or \$15.00 per month. Specific rates will be provided after the grant of ETC status and prior to commencement of service offerings, and all rates, terms and conditions of Applicant's Lifeline service will be maintained on a publicly available website. Mercury Wireless does not currently have any plans to use agents or independent contractors to sign up subscribers.

8. Mercury Wireless will satisfy all applicable consumer protection, consumer privacy, and service quality standards. See <https://www.mercurywireless.com/legal-policies/>

9. ; To the extent applicable, Applicant will comply with the Cellular Telecommunications and Internet Associations Consumer Code for Wireless Service.

10. Mercury Wireless has an existing policy which provides that any new customer requesting service within a service territory will typically receive it within five (5) business days of inquiry.

11. Applicant will remit all required and collected 911 revenues to the appropriate local authorities.

12. Mercury Wireless is financially sound and technically capable of expanding its voice telephony services and territory. It has been provisionally awarded \$1.6 million in CAF II funds to support services in Missouri. It will be supported by its parent, Mercury Wireless, Inc. Confidential financial information is submitted herewith as **Exhibit "D"**.

13. Mercury Wireless will not initially be providing directory assistant services, operator services or landline interexchange services, but customers will have access to such services provided by others.

III. MERCURY WIRELESS SATISFIES THE COMMISSION'S AND THE FCC'S REQUIREMENTS FOR ETC DESIGNATION FOR HIGH-COST SUPPORT (4 CSR 240-31.130(F) and 47 CFR PART 54 SUBPART C).

1. Mercury Wireless will comply with all the requirements as set forth in 47 CFR Part 54, Subpart C. To that end, Mercury Wireless will, upon ETC status being granted, comply with the applicable service requirements of 47 CFR 54.201(d), as more fully described above.

2. Designation of Mercury Wireless as an ETC for high cost support purposes will further the goals of the CAF II program and will benefit Missouri consumers. Specifically, the Company will offer broadband and IP voice over fixed wireless systems. With the current industry infrastructure available to service much of Applicant's proposed Territory, access to

broadband Internet service is unavailable, unaffordable or unreliable. Mercury Wireless understands, as do the FCC and the Commission, that accessible and reliable internet connectivity is becoming increasingly popular, and in many respects, necessary component of daily life of family households, businesses, and community anchor institutions. Mercury Wireless will help make broadband available to such homes, businesses, and community anchor institutions in areas that do not, or would not otherwise, have broadband.

3. Because Applicant seeks ETC status for the purposed of developing and operating services pursuant to CAF II, to address the requirements of 4 CSR 240-31.130(1)(F) it submits herewith a copy of its provisionally successful bid for CAF II funding as **Exhibit "E"**. It has not obtained any FCC waiver.

IV. MERCURY WIRELESS REPOSSES TO REGULATORY AND OTHER INFORMATION REQUIRED BY 4 CSR 240-31.130(1)(C) & 4 CSR 240-31.130(1)(E).

1. Mercury Wireless is a wholly-owned subsidiary of Mercury Wireless, Inc. Owners owning a 10% or greater interest in Applicant (indirectly, through Mercury Wireless, Inc.) are as follows: Garrett Wiseman

3. Applicant shares common ownership or management with Mercury Wireless, Inc a Kansas corporation.

4. Mercury Wireless, Inc. and its other subsidiaries offer telecommunications services, IVOIP, and wireless services in other states, but have not yet received FUSF or state universal service funds.

5. Upon being granted ETC status, Applicant hereby commits to notify the Commission of any changes to Applicant's contact information.

6. Mercury Wireless has filed for registration with the PSC as an iVOIP provider.

7. Neither Mercury Wireless, nor any of the aforementioned affiliates or owners, have had an action brought against them in the last ten (10) years by any state or federal regulatory or law enforcement agency involving any aspect of state or federal universal service funds and programs, fraud, deceit, perjury, stealing, or omissions of material fact.

8. Mercury Wireless does not currently participate in any FUSF funding.

9. Mercury Wireless understands that the Commission is undertaking a "streamlining" of its ETC application rules. Accordingly, while it has endeavored to meet the current rules, Mercury Wireless requests a waiver from strict compliance with the Commission's currently effective rules.

WHEREFORE, Mercury Wireless respectfully requests that the Commission as expeditiously as possible issue an order designating the Applicant as an ETC in Missouri throughout the service area specified above for the purpose of receiving federal support in connection with the Connect America Fund II broadband initiative and related federal support for the provision of Lifeline services, and grant such other and further relief as the Commission deems appropriate including waiver of the strict application of 4 CSR 240-31.130 as more fully discussed herein.
