ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: September 1, 2009 Effective Date: September 11, 2009

On August 4, 2009, the Staff of the Commission filed a motion asking the Commission to cancel the certificate of service authority and accompanying tariff of Communicate Technological Systems, LLC ("Communicate"), a company that has been authorized to offer intrastate interexchange telecommunication service by the Commission.

In File Number TA-99-537, the Commission granted Communicate a certificate to provide intrastate interexchange telecommunications services. Communicate's tariff, P.S.C. MO No. 1, was also approved.

Staff states in its motion that Communicate is deficient in the filing of the Company's calendar year 2006, 2007, and 2008 annual reports. Communicate owes no past assessments to the Commission and Staff believes Communicate is no longer providing telecommunications services in Missouri. Staff recommends that the Commission cancel the company's certificate of service

authority and accompanying tariff, P.S.C. MO No. 1, to provide intrastate interexchange telecommunications services.

On August 6, 2009, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than August 17, 2009. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion and because Communicate is not providing telecommunications service in Missouri, the Commission finds that the certificate of service authority and accompanying tariff granted to Communicate Technological Systems, LLC, shall be canceled.

IT IS ORDERED THAT:

- The certificate of authority to provide intrastate interexchange telecommunications services granted to Communicate Technological Systems, LLC, in Case Number TA-99-537, is canceled.
 - 2. Communicate's tariff, P.S.C. MO No. 1, is canceled.
 - 3. This order shall become effective on September 11, 2009.

4. This case may be closed on September 12, 2009.
