Enclosed for filing with the Missouri Public Service Commission (Commission) on behalf of Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers), please find in electronic format certain water tariff sheets (list attached).

These tariff sheets are being filed to incorporate new, previously unregulated water assets of The Missing Well, LLC ("Missing Well") and Ozark Clean Water Company ("Spring Branch") into Confluence Rivers' existing tariff, P.S.C. MO No. 12 pursuant to the Commission's *Order Granting Certificate of Convenience and Necessity* issued in Case No. WA-2021-0425.

In relevant part, Confluence Rivers was directed as follows - "Confluence Rivers shall set monthly rates for The Missing Well at a flat rate of \$20.00 monthly for water service[.] Confluence Rivers shall adopt the current existing water and/or sewer rates for Spring Branch[.] Confluence Rivers shall submit tariff sheets for . . . The Missing Well . . . and Spring Branch to become effective before closing on the assets, to include a service area map, service area written descriptions, rates and charges to be included in its EFIS tariffs P.S.C. Mo No. 12[.]" Confluence Rivers expects to begin closing on the assets that are the subject of this case on December 28, 2021.
